How does DontSendMeACard work for charities?

How do I register my organisation?

Please sign up here and create a basic email username and password, and you'll then be able to complete our charity registration form.

I've tried to register but have ended up in the User Account, how do I complete my registration?

This can happen as we ask you to create a basic User ID first. The main reason that the charity form fails is that the logo you are trying to upload is too large a file size. Please upload a JPG file under 1MB, ideally 600x600 pixels.

To get back to the form go to Edit Profile, and click Register as a Charity in the footer.

What payment methods can we receive donations with?

We use PayPal as our payment gateway. You need to provide the email associated with your PayPal account when registering to automatically receive donations.

Can we upload our own e-card artwork?

Yes you can upload your own e-card designs. Once you have access to the charity dashboard you can follow the instructions under the Resources tab.

Is there a cost to upload our own designs?

No. It's offered as part of the charity dashboard fundraising system.



Measure the performance of each e-card design uploaded.

Can I measure the performance of my designs?

Yes we've built an artwork performance tool where you can view how each of your designs has performed. We match up the donation amounts with your card design and display a total raised. Go to Card Performace in the dashboard.

What are the costs involved?

There's no setup charge or monthly fee for charities. We charge a small fee on each transaction along with PayPal's processing fees. There are additional optional customisations that you can hire us to perform – please go to the Customisations tab in the dashboard.

How do I collect the data required for Gift Aid?

In the charity dashboard go to the Gift Aid and Donor Email tab.

Please note that we offer the ability to collect the data required for Gift Aid, we don't process Gift Aid for you as an agent.

Are you GDPR compliant?

Absolutely. We're a light-hearted alternative to cards but we take operating a fundraising platform seriously. Any data collected is by consent from the user. Data is accessible via secure CSV download.
